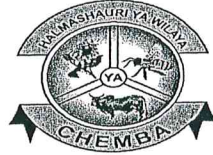


### INVITATION FOR BIDS

1. The Government of Tanzania has set aside fund as a financial assistance from Development Partners and Government towards the cost of Water Sector Development Programme (WSDP) for the financial year 2016/2017 and intends to apply part of funds to cover eligible payments under the Contract for implementation of water supply schemes in Chembe District Council.
2. The **Chemba District Council** now invites sealed Tenders from eligible and qualified **Civil Engineering Contractors** registration Board (CRB) in **Class Six (VI) and above** who meet the qualification criteria stated in bid documents.
3. The Scope of works commonly comprise of three lots approximately the following major quantities in all respective packages:-

4. Tendering will be conducted through the **National Competitive Bidding** specified in the Procurement , 2013 – Government Notice No. 446 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
5. Interested eligible Tenderers may obtain tender documents and further information at the **Tender Board Secretary Office P.O. Box 830, Chemba Dodoma Region** which is located at Chemba Village from **08.00 to 15.30 Hrs**, Monday to Friday inclusive except on public holidays.
6. A complete set of Tendering Document(s) in English may be purchased by interested Tenderers on the submission of a written application letter to the address given under paragraph 4 above and upon payment of a non-refundable fee of **TShs. 100,000.00 (One Hundred Thousands Shillings)**.
7. All Tenders must be accompanied by a **Tender securing Declaration** in the format provided in bidding document, Anti – Bribery Policy and a **Special Power of Attorney** with the Board of Directors' resolution.
8. Site visit will be held on **Friday 26<sup>th</sup> May, 2017** and departure time will be at 09:00a.m starting from Chemba Headquarter offices at Chemba Village. **All costs associated with transportation will be covered by Tenderers themselves.**
9. All Tenders in one (1) original plus two (2) copies, properly filled in, and enclosed in plain envelopes must be delivered to the following address "**The District Executive Director P.O. Box 830, Chemba.**"
10. The deadline for submission of bid document will be on **Tuesday 13<sup>th</sup> June, 2017, at 11:00am** East Africa local time. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at **Chemba District Council Offices, located at Chemba.**
11. Late Tenders, portion of Tenders, electronic Tenders, Tenders not opened at the Tender opening ceremony and Tenders not received shall not be accepted for evaluation irrespective of the circumstances.
